Fee of up to \$5.95 may apply when reloading your card at Green Dot® or Visa ReadyLink reload agents. This fee is charged by the reload agent and is subject to change.

Per purchase without PIN	\$1.00	Domestic purchase fees are waived when you select the Monthly Fee Plan.
Per purchase with PIN	\$2.00	Domestic purchase fees are waived when you select the Monthly Fee Plan.
Bill payment	\$1.00	Bill pay available when you log in to your account at https://secure-cashexpress.pd.gpsrv.com/ . The bill payment fee of \$1.00 per check payment is waived if the payment can be made electronically.
Bill payment stop payment	\$10.00	You will be charged \$10.00 if you ask us to stop payment of a bill pay by check.
Card to bank transfer	\$5.00	\$5.00 per transfer fee applies when you originate an ACH from your Card to a bank account.

ATM withdrawal	\$2.50	This is our fee. You may also be charged a fee by the ATM operator, even if you do not complete a transaction.
Over the counter cash withdrawal	\$2.50	You will be charged \$2.50 each time you make a cash withdrawal through participating banks. This is our fee. You may also be charged a fee from the participating bank.

Per purchase without PIN - International	\$2.00	International purchase fees without using your PIN are \$1.00 when you select the Monthly Plan.
Per purchase with PIN - International	\$3.00	International purchase fees using your PIN are \$1.00 when you select the Monthly Plan.
International ATM withdrawal	\$3.50	This is our fee. You may also be charged a fee by the ATM operator, even if you do not complete a transaction.
International ATM balance inquiry	\$0.50	This is our fee. You may also be charged a fee by the ATM operator, even if you do not complete a transaction.
International over the counter cash withdrawal	\$3.50	You will be charged \$3.50 each time you make an international cash withdrawal through participating banks. This is our fee. You may also be charged a fee from the participating bank.

Card Replacement orders (standard delivery)	\$4.00	You will be charged \$4.00 per card for standard delivery arriving in 7-10 days. We will not charge this fee for the first replacement card order.
Card Replacement orders (expedited delivery)	\$29.00	You will be charged \$25.00 for expedited delivery of a Card, in addition to \$4.00 per replacement card after one free replacement.
Inactivity	\$7.00	You will be charged \$7.00 each month after 90 days of no activity. Activity includes purchases, cash withdrawals, loads, payments and declined transactions.
Fee plan changes	\$2.00	We will not charge you this fee for your first two (2) fee plan changes (from Pay as You Go to Monthly Fee Plan, or reverse).
Balance refund checks	\$2.00	When you close your account and request a check for the balance mailed to you, you will be charged \$2.00.
